If a project involves different types of activities, should it be broken down by activity or grouped under a single activity?

If a project consists of multiple activities, the activities must be broken down, considering the sector and monitoring framework indicators, as well as the territorial coverage (Admin1).

Will we receive a single file with all the information for all sectors?

If your organization is new, you should download the file from the key resources page at <https://www.r4v.info/en/keyresources2023>.

In the case that your organization is already part of the RMRP, you will receive an Excel file from the information management focal points containing the activities submitted by your organization's focal point the previous year. If you haven't received it, please get in touch with the information management team of the R4V platform in your country. Contact information can be found at the end of this document.

Will new activities undergo reviews for GAM, environmental, AAP, and PSEA markers?

No, since this is a midterm review, such reviews will not be required.

When will we receive the template?

If your organization already submitted a plan for the RMRP 2024, you will receive the Excel template with the activities submitted the previous year. If you haven't received this information by **August 31st**, please contact the relevant information management focal point for your country. Contact information is available in the final section of this document.

I submitted the activity template in 2022, but we haven't received confirmation. Whom can I contact?

Upon submitting the activities using the form, please note that you will receive an email from the account platformr4v@gmail.com confirming the submission of activities. If you haven't received the email, please contact the information management focal points corresponding to your country, as listed in the final part of this document.

Is it possible to consider impacts/changes generated by contextual changes such as the climate crisis?

Yes, it is possible. These can be considered as new activities. Additionally, please consider that if there is a contextual change in your territory, proposed activities can be eliminated or modified accordingly.

I belong to a partner organization that submitted activities the previous year without any changes in the planning. Is it necessary to submit activities through the submission form shown in the webinar?

No, it's not necessary. If your organization did not find it necessary to make changes to the activities for 2024, the R4V platform will assume that the activities submitted the previous year remain valid.
